#### 1. General

### 2.2 Personal data collected automatically:

## 3. Saving of and access to personal data

The personal data communicated or collected in this way expressly or automatically are integrated and processed in the Wix.com file.

### 5. Purpose of the processing of personal data

### 11.1. What are cookies?

third parties and are a necessary source of income. Examples of advertising cookies are:
